The Court, having reviewed the Proof of Service and Military Service Declaration and being fully informed, pursuant to the Servicemembers Civil Relief Act, finds and orders that:

- (1) The  Plaintiff  Defendant is in default.
- (2)  The Military Service Declaration shows that the defaulting party is not in military service. Therefore the Default Judgment is granted.
- (3)  The Military Service Declaration shows that the appearing party does not know the military service status of the defaulting party. The Default Judgment is granted, and the appearing party:
  - does not need to file a bond;
  - OR
  - must file a bond in the amount of \$\_\_\_\_\_.
- (4)  The Military Service Declaration shows the defaulting party is in military service. The court appoints an attorney to be determined to represent the non-appearing party. The action is stayed for 120 days from this date.
- (5)  The Military Service Declaration is insufficient, and the Default Judgment is denied.
