Ownership of a substantial interest is defined in U.C.A. 10-3-1303(9) as the ownership, either legally or equitably, by an individual, the individual's spouse, or the individual's minor children, of at least 10% of the outstanding shares of a corporation or 10% interest in any other business entity.

*Note: There is no case law or statutory guidance as to what constitutes a business entity "subject to regulation of the municipality." A business which is simply issued a business license by the municipality may or may not be deemed by a court, administrative agency, an auditor, or member of the public to be an entity regulated by the municipality. Businesses regulated by interlocal agencies of which the municipality is a member may or may not be deemed to be a business regulated by the municipality (i.e., a restaurant subject to regulations imposed by an interlocal agency).

A business entity which requires a conditional use permit to operate may more likely be deemed to be a business entity regulated by Heber City than a business that simply receives a business license from Heber City.
